Finance Council: Pam reported

Christian Women: Dennis reported- Baby Bottle Campaign donations to be turned in by Father's Day.

Liturgy Committee: No meeting until late summer- We will have a Father's Day & Graduate Blessing at Masses

Building & Maintenance: Septic System update: Fee of \$1000 for testing and results of our system. This is a necessary first step- the information we receive can transfer to any company that may work on this project. The area is the field on the west side, past the cemetery shed. The holding tank is under the grass by Father's house. Storm Door updated at cost of \$900. There is a 4 – 8 week lead-time on the door. The lighting, for both the Parish windows and Cross, has been donated along with a Timer Switch for both bathrooms. Back door closer is not working properly and should be looked at. The Main Entrance doors are old and there are concerns with the integrity of the glass (safety being the primary motivation, along with expense of replacing/repairing vs new). A suggestion to replace the doors, at a cost of \$11,625, was made by Dennis. Motion by Scott w/second from Randy and approved by all.

School Hill Athletic Club/Men's Club: Miranda reported that a new lighted sign is being looked into. Confirming it would be acceptable to the Parish. They've asked that we keep them updated on the status of the septic project.
