Corrigan Construction estimated \$20,893/side (North & South sides). AC for back room \$4,000 for 1-ton large size- checking on size needs/price. Water sample test sent to Manitowoc County came back as OK. For Perch Fry we are buying Pike Perch early. Signed snow removal contract. Proxy on Ambry; Ruth suggested minimal revisions on wording in the letter/ document.
